**BOOTHS:** Booths are approximately 10'x10'. Spaces are assigned on a first-sign up/first-paid basis or at the show coordinators discretion.

**VENDOR FEES:** Indoor spaces = \$25 each

**SETUP:** Set up will be Friday from 5pm - 10pm. All vendor displays must remain intact until 5pm Sunday. Please note: that there is NO event security. The only security at the event is the bank alarm system.

**TABLES:** Exhibitors will be able to rent tables for a fee of \$5.00 each. Chairs will be provided at no charge.

**HOSPITALITY:** You will have a vendor host to meet you, guide you to your space, answer questions and stay at the event the entire show.

**PARKING:** A designated parking area will be provided for vendors behind the bank. Your booth fee includes 1 parking pass.

Vendor/Exhibitor Agreement

1. Remember this is an antique and collectibles show. No crafts or new items. No firearms or pornographic material of any kind (for example: videos or magazines). All items must be marked. The hosts reserve the right to make all final decisions concerning the standards of the Exhibitor. Exhibitors shall be open for business during all show hours.
2. The Chamber of Commerce is responsible for space assignments. Every effort is made to accomodate location requests; however the Chamber reserves the right to assign a different location if it is in the best interest of the show. We reserve the right to limit the number of booths with similar items.
3. First time applicants need to describe the type of items you plan to sell with your application form and booth payment. If your booth is not accepted, we will return payment as soon as possible.
4. Exhibitors are responsible for collecting, reporting, and paying sales taxes.
5. All Exhibitors will be featured inside Citizens Guaranty Bank, 25 River Drive, Irvine, KY. Exhibitors must set up their booths in a professional manner and keep the booth area clean at all times. All containers and boxes must remain under exhibit tables.
6. Exhibitors will be able to rent tables for a fee of \$5.00 each. Chairs will be provided at no charge. Exhibitors are responsible for bringing their own extension cords. Limited electricity will be provided to some booth areas.
7. The Estill County Chamber of Commerce will check all booths for adherence to policies and advise exhibitors of infractions that require immediate attention.
8. No Exhibitor shall break down their booth or leave the show prior to 5pm Sunday. Exhibitors must clean their booth space at the end of the show. Any damages to premises must be paid for by the Exhibitor.
9. Once a reservation has been made, we regret that we will not be able to make a refund.

10. No pets will be allowed in the bank.
11. The bank is a smoke free building and there are designated smoke areas outside the building.
12. There will be designated parking for Exhibitors behind the bank. You may unload your items at the side door under the bank canopy and may use the elevator if your booth is located on the top floor. You will receive a parking pass for one vehicle to be parked in the designated area.
13. It is understood and agreed that neither the show sponsors, the Estill County Chamber of Commerce, the City of Irvine, volunteers, hired help or other personnel shall be liable to Exhibitor for any personal injury or property damage, whether by accident, fire, theft, breakage, or from any other cause. Further, Exhibitor agrees to indemnify and hold harmless each said party from any claim of personal injury or property damage to third parties arising from the operation of said booth.
14. The Estill County Chamber of Commerce, Citizens Guaranty Bank or City of Irvine is not responsible for loss or damage to your property before, during or after an Event. The bank alarm system will be armed to protect your booth display.
15. Booth size is approximately 10'x10' and locations will be assigned on a first come first basis. Complete booth rental fee is due with application. Show is rain or shine. **YOU ARE PROHIBITED FROM NAILING, TAPING OR HANGING ANYTHING ON THE WALLS OF THE BANK.**
16. For a guaranteed spot, applications are due no later than March 31, 2010. Upon receipt of your application, a confirmation letter and site assignment will be mailed to you. Payment is due by March 31, 2010.
17. Promotion will include press releases to regional newspapers, radio stations, magazines, television stations, websites, and Kentucky Arts Council.
